

## **Lobbyist Registration Instructions**

### **Lobbyist Registration**

Per Illinois Statute 25ILCS170, in order to lobby the DuPage County Chairman or County Board Members, the lobbyist must be registered with the DuPage County Clerk. The Lobbyist Registration form can be downloaded from <http://www.dupageco.org/countyclerk>.

### **Lobbyist Financial Report**

In addition to Registration, for every year that lobbying activity is performed, a Lobbyist Financial Report must be filed with the County Clerk. The Lobbyist Financial Report form can be downloaded from <http://www.dupageco.org/countyclerk>.

### **Submittal of Lobbyist Forms**

The forms must be completed, printed and signed.
