OWNER AUTHORIZATION – Authorization by owner of the property to agent for execution of Building & Use Permit. The undersigned states that he/she is an owner of the above described property. If property is owned by a corporation, this authorization must be signed in the name of the corporation, by the President or Vice-President of the corporation, attested by its Secretary, if any.

HOMEOWNER ASSOCIATION AFFIDAVIT – Authorization by Homeowner Association for execution of Building & Use Permit. The undersigned state that he/she is an officer of the _____ HOA for the above described property. This homeowner association is authorized by the owners to make application for the proposed work stated on the building application pursuant to an agreement between owners and association. The owners have delegated responsibility for performing the proposed work listed on the permit application to the association.

ASBESTOS AFFIDAVIT – I acknowledge that I will adhere to the complete statutory and regulatory requirements found in the Illinois Environmental Protection Act 415 ILCS 5/8 et seq. and Title 35 of the Illinois Administrative Code of Regulations. Failure to comply shall render any permit issued by the County null and void and without further effect. I recognize should any permit be deemed null and void I am obligated under the laws and ordinances of DuPage County to immediately cease and desist activity and/or remove all improvements erected, built, constructed or relocated by virtue of the permit at my own expense.

UTILITY AFFIDAVIT – (Structures installed in a utility easement on property) I acknowledge my responsibility to contact all utility companies regarding the placement of a structure within the utility easement on my property.

UTILITY SHUT OFF (for demolition) I acknowledge that all utilities are or will be shut off at time of demolition.

PLUMBING AFFIDAVIT – (owner, owner occupant, lessee doing the plumbing work) 225 ILCS 320/3 Nothing shall prohibit the owner occupant or lessee occupant of a single family residence, or the owner of a single family residence under construction for his/her occupancy, from planning, installing, altering or repairing the plumbing system of such residence provided the plumbing complies with the minimum standards for plumbing contained in the Illinois State Plumbing Code and the DuPage County Building Code; plumbing work is subject to inspection by the Illinois Department of Public Health or DuPage County; if employing a person to assist them, he/she must have an Illinois Department of Public Health Plumbing Contractor Registration Certification that allows he/she to perform as a contractor; friends, relatives etc. may not assist, layout or install the plumbing work unless they are certified by the Illinois Department of Public Health Plumbing Contractor Registration and licensed as a plumber by the State of Illinois. (An occupant is someone who has taken possession of and is living in the premises as his/her bona fide sole and exclusive residence, or in the case of an owner of a single family residence under construction for his/her occupancy expects to take possession of and live in the premises as his/her bona fide sole and exclusive residence and occupy such for not less than 6 months after completion of the plumbing work performed or in the case of construction, occupy after completion of construction for not less than 6 months.) If not strictly adhered to or misrepresented the permit will be immediately rescinded. Any plumbing installed not in accordance with the above guidelines may be required to be removed at the discretion of the County's Plumbing Code Enforcement Officer or the Regulatory Services Manager. I have read and understand the above information as it applies to the Illinois Plumbing Code and Plumbing License Law as it pertains to my permit and my representation that I or my lessee will be completing the plumbing work as specified in the listed permit.

MERCURY THERMOSTAT AFFIDAVIT – I acknowledge that prior to commercial demolition I adhere to the complete statutory and regulatory requirements found in the Illinois Environmental Protection Act 415 ILCS 98/51 – (Sec. 51) and Title 35 of the Illinois Administrative Code of Regulations. Failure to comply shall render any permit issued by the County null and void and without further effect. I recognize should any permit be deemed null and void I am obligated under the laws and ordinances of DuPage County to immediately cease and desist activity and/or remove all improvements erected, built, constructed or relocated by virtue of the permit at my own expense.
