8. You have rights in paying for your care, and getting Medicare and Medicaid.

## Long Term Care

Placement in a long term care facility may be the only option available when the needs of an older adult can no longer be met by family, friends, or through community services. Decisions regarding placement need to be made with care to ensure the best interest of the individual.

Selecting an appropriate facility requires thorough research. Visit several facilities informally, using the checklist on Page 3 to help answer your questions and to identify long term care facilities that have characteristics you consider important. Schedule an appointment with the administrator or the director of admissions at the facilities being considered. Whenever possible, the prospective resident should be involved in the decision making process. For detailed information about the performance of every Medicare and Medicaid certified long term care facility, go to [www.medicare.gov](http://www.medicare.gov). Following placement, visit frequently and remain involved in the resident's care. If concerns and/or complaints arise, a referral can be made to the Long Term Care Ombudsman Program. (See Page 5)

Effective since July 1, 1996, all nursing facility applicants, regardless of payment method, must have a Choices for Care pre-admission screening completed before they can be admitted to a nursing home. (See Page 4)

# Choices For Care

**WHAT?** Choices for Care is a legally mandated, comprehensive assessment by a professional case manager to determine the appropriateness of long term care facility placement, to discuss eligibility for Medicaid, and to provide information on alternative home and community-based services. The assessment considers a person's functional ability, as well as the support they are currently receiving from family, friends and other sources. **All long term care facility applicants retain the right to choose long term care facility admission even if it is not recommended.**

**WHY?** Effective since July 1, 1996, all long term care facility applicants, regardless of payment method, must have a pre-admission screening completed before they can be admitted to long term care facility. (Public Act 89-0021).

**WHERE?** Case Managers will complete a Choices for Care assessment in the hospital or in a client's home.

**WHEN?** A Choices for Care assessment should be requested when the decision has been made that long term care placement may be necessary. Although screenings may be completed at any time prior to admission, it is recommended that they be requested as soon as possible. The screening is good for 90 days.

## Levels of Care

### SKILLED CARE

Skilled Nursing Facilities provide 24-hour patient care including medical, nursing, dietary, pharmaceutical and rehabilitative services. This level of care comes closest to hospital care. Medicare and Medicaid will pay for eligible residents in a certified facility.

### INTERMEDIATE CARE

Intermediate Care Facilities provide in-patient care for residents who need nursing supervision and supportive care, but who do not require continuous nursing care. Individuals with relatively stabilized long term illnesses or disabilities, including mental illnesses, are appropriate for this level of care. Medicaid pays for qualified recipients in an Intermediate Care Facility.

### SHELTERED CARE

Sheltered Care Facilities provides a supervised setting for individuals who need a protective environment. Residents do not require nursing care, but need assistance with meals, dressing, walking, and personal care. Periodic medical exams and other medical services are provided when needed. Medicare and Medicaid will not pay for this level of care.

# Choosing a Long Term Care Facility

When choosing a long term care facility, ask the following questions:

1. Is the home licensed by the state, and when was the last licensing survey completed? Ask to see a copy of the most current report.
2. What services are covered by the monthly rate and what charges may be covered by Medicare, Medicaid, and/or private insurance?
3. Would there be a problem transferring from Private Pay to Medicaid? Does the nursing facility have a limited number of beds that are Medicaid only?
4. How are residents' medical needs met? Does the nursing facility have an arrangement with a local hospital to handle emergencies? Do the residents look well groomed?
5. What are the policies regarding access to medical records and discharge?
6. Are special diets accommodated? Is congregate dining available and encouraged? Can meals be sampled?
7. Does the facility have pleasant and safe surroundings, i.e., call bells and grab bars in bathrooms and bedsides, automatic sprinkler system for fire, and clearly marked fire exits?
8. Is the home reasonably free of unpleasant odors? Are the grounds maintained?
9. Does the staff treat residents with kindness, courtesy and respect? Are provisions made for residents who speak a foreign language?
10. Are both individual and group activities scheduled? Is a copy of the monthly activity calendar visible?
11. What are the visiting hours? Are they convenient to prospective visitors?
12. Are residents given privacy and allowed to keep some personal belongings?

## **Long Term Care Ombudsman Program**

This program, which is authorized by federal law and implemented by state law, advocates for the rights and improved living conditions of persons in long term care facilities, licensed assisted living and supportive living.

An ombudsman represents and advocates for long term care facility residents. An ombudsman receives, investigates and attempts to resolve all concerns and/or complaints regarding the care of residents; visits all facilities on a regular basis; educates residents, family members and concerned citizens about residents' rights.

## ILLINOIS DEPARTMENT OF PUBLIC HEALTH (IDPH)

Long term care facilities must meet the licensing requirements of the Department of Public Health, and must comply with federal and state rules and regulations. Facilities must pass an annual certification survey completed by a public health survey team, and keep them on file for at least 5 years. Information on nursing homes and survey results is available at [www.medicare.gov](http://www.medicare.gov).

IDPH is required to investigate all complaints they receive against long term care facilities. Complaints may be filed in writing, in person, or by calling the toll-free Nursing Home hotline:
