NOTICE OF FUNDING AVAILABILITY 2019 PROGRAM YEAR

COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM (CDBG) AND EMERGENCY SOLUTIONS GRANT PROGRAM (ESG)

The DuPage County Community Development Commission hereby announces the availability of funding and the application process for the 2019 program year. Applications for Public Services (Emergency Shelter, Street Outreach, Homeless/At-Risk Homeless Services, Homeless Prevention/Rapid Rehousing/Financial Assistance), Neighborhood Resource Centers, and Non-Profit Capital Projects (acquisition, rehabilitation, new construction, ADA renovation) will be accepted. Agencies seeking funding (including those agencies administering homelessness prevention and rapid re-housing pooled funds) must complete each of the following steps:

1. Attend a mandatory meeting on August 24, 2018, as follows:
 - Public Services and Neighborhood Resource Centers – 10am to 11am in room 3-500b, 421 N. County Farm Road, Wheaton, IL 60187
 - Non-profit capital projects – 11:00am to 12:00pm in room 3-500b, 421 N. County Farm Road, Wheaton, IL 60187
2. Submit a Letter of Intent through the on-line application process. The letter must be submitted by 4:30pm on **September 7, 2018**. Any agency that does not submit a Letter of Intent by the required date and time will be disqualified from the application process.
3. Participate in a public hearing to explain their project to interested stakeholders. This can be a group public hearing with other agencies, or a public hearing held individually by the applicant. Published notice of the public hearing must be done at least ten (10) calendar days prior to the public hearing and the hearing must be accessible to those with physical or language barriers. A sample public hearing notice will be provided at the mandatory meeting.
4. Submit an Application through the on-line application process. The Application must be submitted by 4:30pm on **October 5, 2018**. Any agency that does not submit the Application by the required date and time will be disqualified from the application process.
