IN THE MATTER OF THE
DISSOLUTION OF THE FAIRVIEW FIRE PROTECTION DISTRICT) Case No. No. 2014 MR 649

THIS MATTER, coming before the Court for entry of an Order pursuant to the Local Government Reduction and Efficiency Act (55 ILCS 5/5-44005, et seq., West), this Honorable Court hereby Orders as follows:

- a) The terms of Lawrence Budnik, James Downey and Ronald Paprocki, as Trustees of the Fairview Fire Protection District, are hereby immediately terminated; and
- b) Richard J. Tarulis is hereby appointed the trustee-in-dissolution for the Fairview Fire Protection District; and
- c) Richard J. Tarulis shall be entitled to compensation for his work as the trustee-in-dissolution for the Fairview Fire Protection District in the amount of \$0 for the first twenty (20) hours of such services, but at the rate of one hundred eighty –five dollars and no cents (\$185.00) per hour for any services performed after the twentieth hour to be paid from the District’s available funds, if any; and
- d) The Petitioner, by and through his attorney, shall give notice of this Order, to: i) Lawrence Budnik, James Downey and Ronald Paprocki, as Trustees of the Fairview Fire Protection District; ii) Richard J. Tarulis, as trustee-in-dissolution for the Fairview

Fire Protection District; iii) Gary King, as Secretary of the Fairview Fire Protection District; and iv) Gwen Henry, as Treasurer of the Fairview Fire Protection District; and

e) This matter shall be continued to September 5, 2014 at 9:00 A.M. in Courtroom 2007 for a [final] status report on the dissolution of the Fairview Fire Protection District and any such other matters as the Petitioner or trustee-in-dissolution may bring before the Court including, but not limited to any order to dispose of remaining District assets or otherwise facilitate the District's dissolution.
