ORDER

This matter coming before the Court, the Court having jurisdiction over the parties and the Subject Matter, for status on the dissolution of the North Westmonet Fire Protections District ("District"), the Court hereby finds as follows:

1. The Court appointed trustee in dissolution ("Trustee") has organized the District's known records for archival and destruction purposes in accordance with state law per the directions of the Illinois Local Records Commission.
2. The Trustee has paid off all of the District's liabilities, excepting fees accrued by the Trustee in Dissolution as provided by the Court's order of July 26, 2018.
3. The Trustee has itemized his expenses via invoice and has tendered that invoice to the State's Attorney's Office for review. The Trustee seeks compensation pursuant to the Court's order of July 26, 2018.

WHEREFORE, the Court hereby Orders as follows:

- a. Prior to June 1, 2019, the Trustee shall provide the Illinois Local Records Commission and Illinois Department of Revenue with a certified copy of this order, and
- b. Prior to June 1, 2019, the Trustee shall closed the district's bank accounts and transfer the balance reflected in the trustee's final report to the control of the DuPage County Treasurer, and
- c. Prior to June 1, 2019, the Trustee shall submit his final invoice for services rendered. The Treasurer shall issue final payment to Michael G. Philipp of Wiedel, Philipp, Indelicato, and Olson, as the Trustee-In-Dissolution, from the remaining District funds, provided that such compensation shall not exceed two thousand dollars (\$2,000).
- d. Following payment of the Trustee, the DuPage County Treasurer shall transfer any sums received from the District's closed accounts to the County of DuPage's general fund per 70 ILCS 705/15(a) which governs the disposition of surplus funds for Fire Protection Districts; and
- e. The District shall be dissolved effective June 1, 2019, and
- f. The appointment of Michael G. Philipp as Trustee is Dissolution shall terminate effective June 1, 2019; and
- g. This case is hereby closed and any further court dates are stricken.
