

**AN ORDINANCE FOR THE LEVY OF TAXES FOR THE CORPORATE PURPOSES OF THE WEST CHICAGO MOSQUITO ABATEMENT DISTRICT, DUPAGE COUNTY, ILLINOIS, FOR ITS FISCAL YEAR FROM MAY 1, 2020 TO APRIL 30, 2021.**

WHEREAS, the Board of Trustees of the West Chicago Mosquito Abatement District, DuPage County, Illinois, did on the 14<sup>th</sup> day of July 2020, duly passed and approved the Annual Budget and Appropriation Ordinance for said District for the fiscal year beginning May 1, 2020 and ending April 30, 2021, the amount of which is estimated to the aggregate sum of \$381,500.00.

BE IT HEREBY ORDAINED BY THE BOARD OF TRUSTEES OF THE WEST CHICAGO MOSQUITO ABATEMENT DISTRICT, DUPAGE COUNTY, ILLINOIS, that there be and is hereby levied upon all the taxable property within the corporate limits of said District, for its fiscal year beginning May 1, 2020 and ending April 30, 2021, said appropriations were made for which this levy is made and the sums so appropriated and levied therefor, respectively are as follows:
