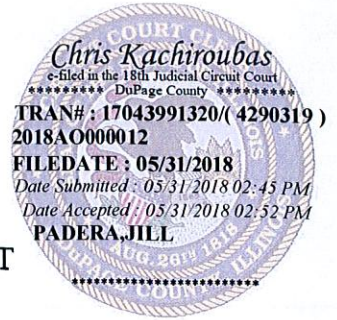

IT IS THEREFORE ORDERED that the list of cases attached hereto and incorporated herein are dismissed and all warrants issued in those cases are recalled.
