WHEREAS, certain felony cases that include drug charges eligible for first offender drug probation have been reassigned to the First Offender Call Unified for Success (F.O.C.U.S.) in Courtroom 4002, a specialty court utilizing trained judges and staff that can uniformly employ evidence-based practices unique to addressing the various issues often present in first-offender drug cases; and

WHEREAS, the 18th Judicial Circuit has two other established specialty courts, being the Mental Illness Court Alternative Program (MICAP) and the Drug Court Program, and their respective Veteran Tracks; and

WHEREAS, it has been determined that certain efficiencies will result from assigning all specialty courts to the same courtroom, while nevertheless ensuring that the respective programs remain independent;

IT IS THEREFORE ORDERED that all current and future Mental Illness Court Alternative Program and Drug Court Program Cases shall be assigned to Courtroom 4002, effective September 24, 2018:
