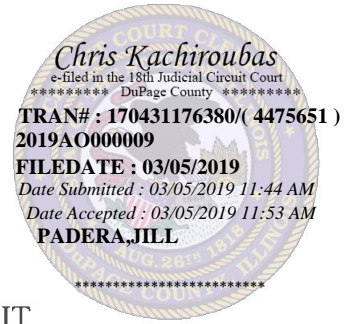

OF AN ASSOCIATE JUDGE)

Pursuant to Section 8 of Article VI of the Constitution of the State of Illinois adopted December 15, 1970, effective July 1, 1971, and Illinois Supreme Court Rule 39, effective July 1, 1971, the Administrative Office of the Illinois Courts having heretofore declared five vacancies in the Office of Associate Judge in this Circuit, and the Chief Judge having given notice to the Bar by posting said notice on each public bulletin board in the courthouse and on the Circuit's website according to custom;

Thereafter, certain attorneys licensed to practice law in this State and seeking appointment to the Office of Associate Judge did file with the Administrative Office of the Illinois Courts application on the form prescribed and furnished by the Administrative Office, and thereafter the Chief Judge did certify to the Administrative Office the names of ten attorneys who filed applications with the Chief Judge and were selected by a Nominating Committee consisting of the fifteen Circuit Judges. Within fourteen days after the names were certified to them, the Administrative Office did place the names of each candidate certified to them from this Circuit on a ballot in alphabetical order and mailed a ballot to each Circuit Judge in this Circuit.


The aforesaid secret ballot having been voted by the respective Circuit Judges and having been returned in the proper envelopes to the Administrative Office who thereafter counted the ballots, tabulated the results and certified to the Chief Judge that the candidates receiving the most votes from the Circuit Judges who had voted were *Susan L. Alvarado, Maureen R. Dunsing, Michael W. Fleming, George A. Ford, and Kenton J. Skarin*, who were declared to be appointed to fill said vacancies.


IT IS THEREFORE ORDERED that *Susan L. Alvarado* be and is hereby appointed Associate Judge of the Circuit Court of the 18th Judicial Circuit of DuPage County, Illinois, effective **March 11, 2019** to serve in said capacity until **June 30, 2019** (McKillip vacancy); that *Maureen R. Dunsing*, be and is hereby appointed Associate Judge of the Circuit Court of the 18th Judicial Circuit of DuPage County, Illinois, effective **March 4, 2019** to serve in said capacity until **June 30, 2019** (Wolfe vacancy); that *Michael W. Fleming* be and is hereby appointed Associate Judge of the Circuit Court of the 18th Judicial Circuit of DuPage County effective **March 29, 2019**, to serve in said capacity until **June 30, 2019** (Walsh vacancy); that *George A. Ford* be and is hereby appointed Associate Judge of the 18th Judicial Circuit of DuPage County, Illinois effective **March 4, 2019** to serve in said capacity until **June 30, 2019** (Davenport vacancy); that *Kenton J. Skarin* be and is hereby appointed Associate Judge of the Circuit Court of the 18th Judicial Circuit of DuPage County, Illinois, effective **March 11, 2019** to serve in said capacity until **June 30, 2019** (Russo vacancy).


