Pursuant to Section 8 of Article VI of the Constitution of the State of Illinois adopted at a Special Election on December 15, 1970, generally effective July 1, 1971, and Supreme Court Rule 39 adopted June 25, 1971, effective July 1, 1971, amended and effective October 14, 1971, thirty-one (31) Associate Judges of this Circuit Court did on or before March 29, 2019 file a Request for Reappointment, the requests being made to the Chief Judge of this Circuit, who then did certify to the Administrative Office of the Illinois Courts the names of the Associate Judges in the Circuit who requested reappointment.

Thereafter, the said office prepared and distributed ballots on which Circuit Judges did vote on the question of whether each said Associate Judge should be reappointed for another term. Circuit Judges did complete their ballots and delivered the same to the said office who thereafter counted the ballots, tabulated the results and certified them to the Chief Judge of this Circuit.
