NOTE

3. Taxes are collected in the subsequent year after levied (e.g., taxes levied in 2019 are collected in 2020).
4. The levy for the Courthouse Bond Debt Service is established per bond ordinance.
5. Illinois Compiled Statute 55 ILCS 5/5-1024 allows the County Clerk to levy a 1% cost of collection factor to: a) County I.M.R.F.; b) Health Department I.M.R.F.; and, c) Courthouse Bond Debt Service. The 1% factor is not reflected in this schedule.
